



## Overview: 2019 Sponsorship Opportunities

IGEL's sponsorship program is built upon its unique environmental leadership program that is conducted over the course of a year. Up to 35 leaders from agriculture, business, industry, government and nonprofits are selected from approximately 100 applicants to participate in this program designed to achieve "mastery of self, mastery of relationship and mastery of action."

The program is conducted in five three-day sessions across Georgia. Here is the 2018 schedule:

- Atlanta, May 14-17, 2019
- Albany, July 9-12, 2019
- Dawson County, September 10-13, 2019
- Sapelo Island, November 12-15, 2019
- Serenbe, January 13-16, 2020

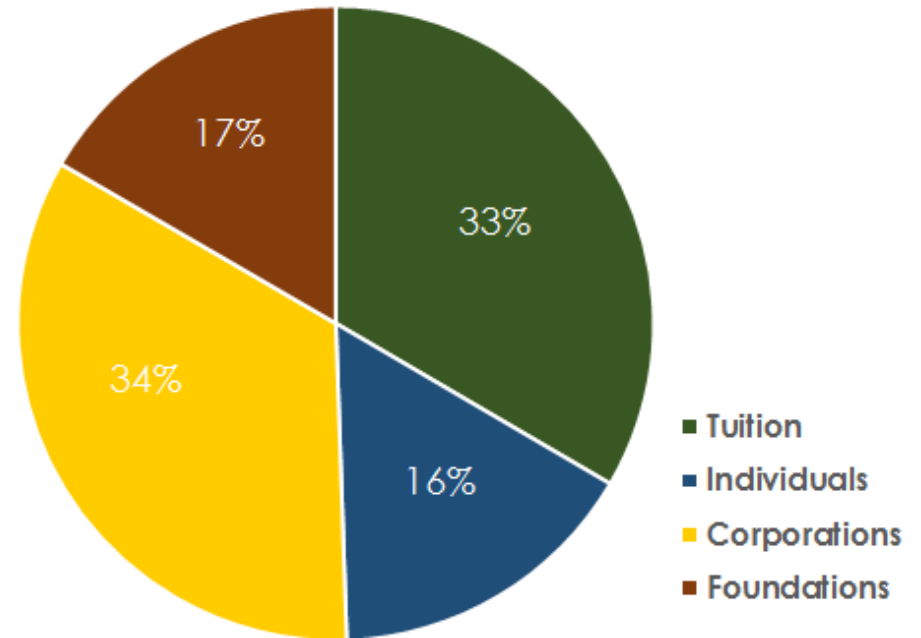
Sponsorship opportunities that are directly tied to the program, which are detailed on the other side of this page, start at the level of meal and progresses accordingly:

## How Your Support Helps

Program expenses for 2018 are expected to be about \$10,000 per participant with tuition covering only 40% of that cost. In addition, many strong candidates are unable to come up with the full amount, so IGEL offers scholarships. In many cases, IGEL would not be able to meet its diversity goals if scholarships were not offered.
